The Grand Jury of Adair County, Kentucky, charges that on or about the 27th day of January, 2022, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant appeared in a public place manifestly under the influence of a controlled substance, or other intoxicating substance, excluding alcohol, not therapeutically administered, to the degree that he may have endangered himself or other persons or property, or unreasonably annoyed persons in his vicinity, against the peace and dignity of the Commonwealth of Kentucky.
