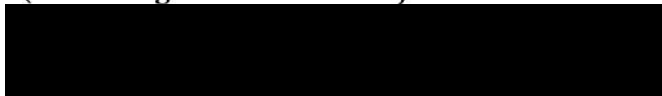




The Grand Jury of Adair County, Kentucky, charges that on or about April 23, 2023, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant operated or was in physical control of a motor vehicle at such time as the Defendant had an alcohol concentration of 0.08 or more as measured by a scientifically reliable test or tests of a sample of the Defendant's breath or blood taken within two (2) hours of cessation of operation of physical control of a motor vehicle; or while the Defendant was under the influence of alcohol; or while the Defendant was under the influence of any other substance or combination of substances which impaired the Defendant's driving ability; or while the presence of a controlled substance listed in KRS 189A.010(12) was detected in the Defendant's blood, as measured by a scientifically reliable test or tests taken within two (2) hours of cessation of operation or physical control of a motor vehicle; or while the Defendant was under the combined influence of alcohol and any other substance which impairs one's driving ability, this being her first such offense within a ten (10) year period, and the Defendant refused to submit to any test or tests of her blood, breath, or urine requested by an officer having reasonable grounds to believe the Defendant was operating or in physical control of a motor vehicle in violation of KRS 189A.010, against the peace and dignity of the Commonwealth of Kentucky.

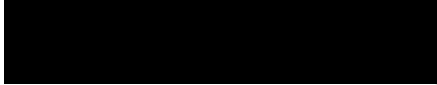

The Grand Jury of Adair County, Kentucky, charges that on or about April 12<sup>th</sup> – 13<sup>th</sup>, 2023, and before the finding of the Indictment herein, in Adair County, Kentucky, the above-named defendant committed the offense of Receiving Stolen Property, \$1,000 or more but less than \$10,000, contrary to KRS 514.110, and at that time the defendant was a person more than 21 years of age, who stood convicted of at least two (2) prior felony offenses, with the previous convictions being convictions of felonies in this state or convicted of crimes in any other jurisdiction, and that a sentence to a term of imprisonment of 1 year or more was imposed therefore, and the defendant was over the age of 18 years at the time the offenses were committed and the defendant completed the service of the sentence imposed on at least one of the previous felony convictions within 5 years prior to the date of the commission of the offense of Receiving Stolen Property, \$1,000 or more but less than \$10,000, contrary to KRS 514.110, or the defendant was on probation, parole, conditional discharge, conditional release, furlough, appeal bond, or any other form of legal release from any of the previous felony convictions at the date(s) of April 12<sup>th</sup> – 13<sup>th</sup>, 2023, or the defendant was discharged from probation, parole, conditional discharge, conditional release, or any other form of legal release on any of the previous felony convictions within 5 years prior to the date(s) of April 12<sup>th</sup> – 13<sup>th</sup>, 2023, against the peace and dignity of the Commonwealth of Kentucky.


