COUNT I

That between January 2022 and September 28, 2024, in Russell County, Kentucky, **Allen Hash** committed the offense of **Sodomy, 1st Degree**, a Class B Felony, in violation of K.R.S. 510.070 as a continuing course of conduct against a vulnerable victim, by engaging in deviate sexual intercourse with another person by forcible compulsion, against the peace and dignity of the Commonwealth of Kentucky.

COUNT II






